A BILL

To amend the Clean Air Act to prohibit any regulation under such Act concerning the emissions of carbon dioxide from a fossil fuel-fired electric generating unit from taking effect until the Administrator of the Environmental Protection Agency makes certain certifications, and for other purposes.

2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Ensure Reliable and
3 Affordable American Energy Act of 2013”.

4 **SEC. 2. NO UNILATERAL REGULATION OF EMISSIONS OF**
5 **CARBON DIOXIDE.**

6 The Clean Air Act (42 U.S.C. 7401 et seq.) is amend-
7 ed by inserting after section 329 the following:

8 **“SEC. 330. NO UNILATERAL REGULATION OF EMISSIONS OF**
9 **CARBON DIOXIDE FROM FOSSIL FUEL-FIRED**
10 **ELECTRIC GENERATING UNITS.**

11 “(a) PROHIBITION ON REGULATIONS CONCERNING
12 EMISSIONS OF CARBON DIOXIDE FROM FOSSIL FUEL-
13 FIRED ELECTRIC GENERATING UNITS TAKING EF-
14 FECT.—

15 “(1) PROHIBITION.—A regulation under this
16 Act concerning emissions of carbon dioxide from a
17 fossil fuel-fired electric generating unit to address
18 climate change may not take effect until the Admin-
19 istrator certifies that a sufficient number of coun-
20 tries have put into effect regulations concerning
21 emissions of carbon dioxide which are at least as
22 stringent as the regulation under this Act.

23 “(2) COUNTRIES.—For the purposes of para-
24 graph (1), the term ‘sufficient number’ means a suf-
25 ficient number of countries so that, in the aggregate,
26 such countries account for not less than 80 percent

1 of the global carbon dioxide emissions, excluding
2 such emissions in the United States, in the calendar
3 year immediately preceding the year in which the
4 regulation under this Act would be enforced.

5 “(3) STRINGENCY CONSIDERATIONS.—For the
6 purposes of paragraph (1), a country’s regulation
7 concerning carbon dioxide emissions may only be
8 considered to be as stringent as the regulation under
9 this Act if such country’s regulation limits carbon
10 dioxide emissions to a numeric standard that is
11 equal to or less than such a standard under the reg-
12 ulation under this Act in a timeframe that is equal
13 to or less than the timeframe under the regulation
14 under this Act.

15 “(b) RULE OF CONSTRUCTION.—Nothing in this sec-
16 tion shall be construed as providing the Administrator
17 with any authority to promulgate any regulation con-
18 cerning, take action relating to, or take into consideration
19 the emissions of carbon dioxide.”.
